2. Upcoming Elementary and Secondary School Emergency Relief (ESSER) II and III Funds			Krey stated that based upon information from the Wisconsin Department of Instruction (DPI), River Valley will receive approximately \$570,000 in ESSER II grant funding. These federal grant dollars have specific "allowable uses" related to the coordination of preparedness and response efforts of local educational agencies to prevent, prepare for, and respond to coronavirus. The committee discussed these allowable uses and how they can relate to current budget items. ESSER II grant money must be utilized before September 30, 2023. In addition, ESSER III federal grant dollars have been approved, but the District has not received specific information regarding the amount from DPI. Districts are required to use 20% of ESSER III funds to address learning loss, while the remaining 80% has identical allowable uses as the ESSER II grant dollars. ESSER III grant money must be utilized before September 30, 2024. Conversation among the group about how this could impact the referendum. In addition, the conversation around allowable costs focused on capital projects across the District and learning loss for students.
