**DESCRIPTION**: 120 acres of school forest property described as follows:

#### Parcel I:

The Northeast Quarter (N.E.1/4) of the Northwest Quarter (N.W.1/4) of Section Twenty-three (23), Township Eight (8) North, Range Four (4) East, Town of Arena, Iowa County, Wisconsin.

#### Parcel II:

The North Half (N.1/2) of the Southwest Quarter (S.W.1/4) of the Northeast Quarter (N.E.1/4), the Northwest Quarter (N.W.1/4) of the Northeast Quarter (N.E.1/4) and the North Half (N.1/2) of the Southeast Quarter (S.E.1/4) of the Northwest Quarter (N.W.1/4) of Section Twenty-three (23), Township Eight (8) North, Range Four (4) East, Town of Arena, Iowa County, Wisconsin.

**MINIMUM PROPOSAL**: The District will accept bids on the purchase of the entire property. The property will not be sold in separate parcels. The minimum bid the District will consider will be \$4,000/acre.

- 1. The property is being sold in "as is" condition. Arrangements may be made to inspect the property through the Business Manager's office.
- 2. The property is zoned A-1 (Exclusive Agricultural) by Iowa County. The District will not be responsible for any rezoning and purchaser will be required to agree to pay any conversion charge (see sec. 74.485, Wis. Stats.) that might be applicable to a change of use of the property.
- 3. The specific closing date has not been fixed. Closing will occur no later than March 21, 2021, unless otherwise mutually agreed.
- 4. The successful bidder, if any, will be required to sign a binding offer to purchase (Form WB-13) within ten (10) business days of notification that his/her/ its proposal has been accepted.

  Closing will occur no later than March 21, 2021, unless otherwise mutually agreed.
